## **COCKERMOUTH GOLF CLUB - RULES (amended 28/01/2018)**

### **NAME:**

1. The Club shall be called "The Cockermouth Golf Club" and shall be a members club.

### **OBJECTS OF THE CLUB:**

2. The object of the of the Club is to provide facilities for and promote amateur participation of the whole community of Cockermouth and surrounding areas in the sport of Golf.

### **CATEGORIES OF MEMBERSHIP:**

3. Membership of the Club shall be open to anyone interested in the sport on application, regardless of sex, age, disability, ethnicity, nationality, sexual orientation, religion or other beliefs, except as a necessary consequence of the requirements of the sport of golf. The club may have different classes of membership and subscription on a non-discriminatory and fair basis. The club will keep subscriptions at levels that will not pose a significant obstacle to people participating. The club committee may refuse membership, or remove it, only for good cause such as conduct or character likely to bring the club or sport into disrepute. Appeal against refusal or removal may be made to the members. The Club shall consist of existing Honorary, Full, Five Day, Academy, Country, Young Adult, Social and Junior Members, and such other categories of Members as the Management Committee shall, from time to time, determine.

The number of members in each of the categories mentioned above shall be determined by the Management Committee.

Honorary, Junior, Country, Five Day Members and non playing Members may be admitted at a reduced subscription at the discretion of the Management Committee. Such members shall have no voting powers excepting Honorary and Five Day Members.

The number of Honorary, Junior, Country, Five Day Members, will not be permitted to exceed the number of Full Members.

Each member playing the course must have a bag of clubs and fix the Membership label to that bag. Members or former members of recognised Golf Clubs are welcome as Visitors. After paying the appropriate green fee they must fix the ticket to the bag, complete and sign the Visitors Book and observe all Rules of Golf and Club Rules. No one excepting Honorary Members is allowed to play the course without first paying the appropriate fee or receiving a Green Fee Ticket, unless playing as a guest of the Captain of the Club or Captain of the Ladies section in which case no fee will be charged. In these cases the Visitors Book must be completed and countersigned by the respective Captain. No other person is authorised to give "Visitors" sanction to ignore this rule excepting those persons authorised by the Management Committee and as ratified by written lease or licence who enjoy the equivalent of Honorary Membership as the result of ownership of land over which the course extends.

Course stewards and Committee Members are authorised to examine Members and Visitors labels and tickets.

Guests of Members, Visitors who have paid a Green Fee and those attending any function organised at the Club may enjoy all the facilities of the Clubhouse subject to the rules of the Club for the time being in force.

Subject to any restrictions which from time to time may be imposed by the Committee, the following persons shall be entitled to admission to the club premises, viz.:-

- (a) Golfers on payment of the appropriate green fee and members' guests;
- (b) Those taking table meals at the premises;
- (c) Those attending any function organised at the club.

### **FULL MEMBERS:**

4. A Full Member of the Club shall only be a person who has paid the full annual subscription for a Full Member or, where so qualified for a senior citizen.

### **HONORARY MEMBERS:**

5. The Management Committee shall have power to elect Honorary Members, upon such terms and conditions as the Management Committee may think proper.

### **JUNIOR MEMBERS:**

6. A Junior Member shall be a person under the age of eighteen years, unless over that age and in continuous education up to the age of twenty one. Juniors currently in full time education and aged between 18 and 21 can apply to join the club paying the appropriate Junior fee. No Junior Member shall be eligible for election as a

Member (except as a Junior Member) unless the Management Committee shall in special circumstances otherwise decide.

A Junior Member will transfer to adult membership on the 1st of January following his/her 18th birthday, or upon ceasing full time education or attaining the age of 21 years.

At that time the Member will be required to pay the entrance fee to the Club in accordance with the amount in force at the time, with the proviso that for each complete year of Junior Membership the entrance fee will be reduced by 25%. The effective date for this reduction will be 1st January following the member's 18th birthday or when he or she ceases full time education or attains the age of 21 years as the case may be.

#### **YOUNG ADULT MEMBERS**

6a. Young Adult membership applies to members who no longer qualify for the junior rate. Members must be over 18 on 1<sup>st</sup> January and under 30 years old. The cost of Young Adult membership shall be determined by the committee. There shall be three categories, 18 to 21, 22 to 25 and over 25 to under 30. This category is to encourage young members to continue membership after being juniors.

#### **COUNTRY MEMBERS:**

7. A Country Member must be a current Member of another recognised Golf Club and reside a minimum of 30 miles from this Clubhouse.

#### **LADY MEMBERS:**

8. Lady members may elect a Ladies Committee consisting of a Lady President, a Lady Captain, a Lady Vice Captain, a Lady Secretary, a Lady Treasurer and such other lady members as they may decide, for the purpose of organising their own section, competitions, matches, handicaps and other social events. The Ladies Committee shall be responsible for financing its own competitions and other functions. Any proposal or arrangement affecting the Club as a whole shall be submitted in writing, to the Club Secretary/Manager and must be approved by the Management Committee before taking effect.

#### **GUESTS:**

9. Members excepting Junior and Social Members may introduce a maximum of three guests each at any one time at a reduced green fee subject to the Member signing the green fee book.

Playing guests may be entitled to pay one half of the normal green fee on condition that they play with the Ordinary Member. Guests, wherever resident may enjoy the facilities of the Clubhouse.

No person shall be entitled to be introduced as a visitor or playing guest more than 6 times in one year.

#### **OFFICERS AND TRUSTEES OF THE CLUB:**

10. The Officers of the Club shall be President, Captain, Captain Elect, Secretary/Manager, Treasurer, Competition Secretary, Subscription Secretary, Captain of the Ladies Section and Vice-Captain of the Ladies section who shall be elected annually at the General Meeting with the exception of the Captain and Vice-Captain of the Ladies Section who shall be appointed as Officers following election at the Annual General Meeting of the Ladies Section. Subject to the provisions contained in these Rules the management of the Club shall be vested in the Management Committee consisting of:-

The Officers, the Trustees and not more than 6 Full Members. The Immediate Past Captain may also sit on the Management Committee at his own discretion with full voting powers. The Management Committee shall have full control of the Management and the Property of the Club.

The longest serving third of the Committee (excepting the Officers and the Trustees) shall retire annually in rotation. In the case of equality of service this shall be by lot and they shall be elected by the Members at the Annual General Meeting. The retiring Members shall be eligible for re-election.

Four Members of the Committee shall form a quorum.

In the event of a Member's appointment lapsing the Management Committee may elect another Full Member of the Club to fill the vacancy for the remainder of the year.

The Trustees of the Club shall be elected by the Members at the General Meeting and shall hold office until death or resignation unless removed by resolution of Members in General Meeting convened for that single purpose.

The Trustees shall be ex-officio Members of the Management Committee. The number of Trustees shall not be more than 4 or less than 2, and the property of the Club shall be vested in them. They shall deal with the property as directed by resolution of the Management Committee (of which an entry in the Minute Book shall be conclusive evidence) and they shall be indemnified against all risk costs and expenses out of the assets of the Club.

The Management Committee shall have power to appoint sub committees for such purposes and with such powers as it may deem necessary and may nominate any Members of the Club whether Members of the Management Committee or not, to serve on such sub committees. Each sub committee shall be under the chairmanship of an elected committee member.

All Members of whatever category shall be bound to submit to the Rules and Bye-Laws of the Club and to such additions thereto, and modifications thereof, as may from time to time be made in accordance with the provisions of these rules and shall accept as final the interpretation thereof and decisions thereon by the Management Committee.

The Captain (or in the case of his absence the Captain Elect) shall preside at all meetings of the Management Committee and in the case of an equality of votes shall have a second or casting vote.

No employee of the club shall be eligible to serve on the Management Committee.

The Management Committee shall be empowered to appoint any bank, building society or other financial institution to be bankers for the club and shall be empowered to authorise any person or persons to (a) sign any cheque and any other type of instrument drawn on such bankers and (b) give any directions or instructions given by any means (including without limitation any one or more of the following means, namely in writing, by telephone, by computer, by facsimile communication or by any other electronic or other means) to such bankers whether in respect of the making of any payments to the debit of any account of the club or in respect of any other transaction or matter of any kind.

#### **MINUTES:**

11. The Secretary/Manager shall keep full and correct minutes of all proceedings of the Club and of the Management Committee and each Sub-Committee, which minutes shall be produced at every meeting of the Management Committee and Sub-Committee as the case may be, and also such accounts as may be required by the Management Committee.

#### **APPLICATIONS FOR MEMBERSHIP:**

12. The election of Members shall be at the sole discretion of the Management Committee, who can elect or refuse membership.

A meeting for the purpose of considering elections for membership of the Club shall be held as often and on such days as the Management Committee may determine.

#### **ANNUAL SUBSCRIPTIONS AND JOINING FEES:**

13. Members shall be liable to pay entrance fees, annual subscriptions, rents or fees for lockers, levies and other payments.

The annual subscriptions to the Club are payable each year on 1st January and shall be such sum as the Full Members in General Meeting shall decide. The Management Committee shall have the power to increase subscriptions by 5% per annum, larger increases or levies to be decided at a General Meeting.

Subscriptions shall be payable on election and subsequently not later than 28th February each year. The subscriptions may be paid in the following manner:-

(a) in a lump sum by 28<sup>th</sup> February.

*(This can be paid by cash, cheque or by using the card machine, at no additional cost) or*

(b) by twelve equal monthly direct debit payments, the first being due on 1st January.

(c) Members must note that to take advantage of the instalment arrangement, a direct debit mandate must be completed by 31<sup>st</sup> December in the previous year.

(d) If none of the above forms of payment are made as above, the person(s) concerned shall no longer be regarded as a member of the Golf Club and will be liable for that current year's subscription

Each Member shall communicate his or her address or that of his or her Banker or Agent from time to time to the Secretary and all notices sent to such addresses shall be considered as duly delivered.

The entrance fee and subscription of a candidate for membership may be modified by the Management Committee at their discretion.

The Captain and the Lady Captain in their year of office shall not be required to pay the individual portion of the Annual Subscription.

Any excess of income over expenditure or refunds of any description from any source will be applied at the discretion of the Management Committee but only in furtherance of the Objects of the Club and no distribution or surplus income or refunds of any description from any source will be made to Members other than on the winding up or dissolution of the Club.

All surplus income or profits are to be reinvested in the club. No surpluses or assets will be distributed to members or third parties.

#### **RESIGNATION AND EXPULSION:**

14. Notice of the intention of a Member to resign or change category of membership must be submitted in writing to the Secretary/Manager on or before 31st December otherwise liability is incurred for the ensuing year's subscription, and the Club will take legal proceedings to recover the sum involved.

Any ex Member having complied with this rule and wishing to rejoin the Club shall be subject to re-election as provided for in Rule 12 and may be required to pay such entrance fee as the Management Committee may decide.

(a) Expulsion of Members - To expel a member from the Club for conduct which, in the opinion of the Management Committee is injurious to the interests of the Club, it shall be necessary that notice be sent to the Secretary/Manager, signed by five members, acquainting him with the circumstances which give rise to such notice. The Secretary/Manager shall then communicate with such member (so that he/she may have the opportunity of explaining his/her conduct in writing or orally, or withdrawing from the Club) and shall call a meeting of the Management Committee who are empowered to decide the question. The member shall be expelled if a two-thirds majority of the Management Committee members present vote for his/her expulsion. Any member so expelled shall have the right to appeal to an Extraordinary General Meeting to be summoned within 21 days of the member's expulsion when a majority of two-thirds of the members present at such Extraordinary Meeting shall be required to confirm the expulsion.

(b) The Management Committee shall have the power to suspend a member for a period not exceeding three months.

#### **GENERAL MEETING:**

15. All Members of the Club (other than Junior Members) shall be entitled to attend at General Meetings. Each Member apart from Social Members shall be entitled to one vote only.

A Chairman shall be appointed for all Meetings, and in the event of a tie in voting he shall have a casting or deciding vote which he must use.

The Annual General Meeting shall be convened as soon as possible after 31st December, and the Secretary/Manager shall post a notice in the Clubhouse at least 28 days before the date thereof together with a copy of the Audited Accounts for the preceding year. Five Full Members shall be present in person to constitute a General Meeting. The business transacted at the Annual General Meeting shall be limited to receiving the Treasurer's report and considering the financial statements for the year ended 30th September, the election of Members of the Management Committee and any Notice of Motion submitted to the Secretary/Manager in writing and signed and seconded by Full Members at least fourteen days before the meeting.

All Notices of Motion should be displayed in the Clubhouse for the benefit of the Members.

The Management Committee has the power to convene General Meetings of the Club.

An Extraordinary Meeting may be called at the request of any TWENTY Full Members who notify the Secretary//Manager in writing. The Secretary/Manager shall post a notice in the Clubhouse convening any Extraordinary Meeting at least fourteen days prior thereto. Nothing affecting the Constitution or Rules of the Club shall be passed except by the votes of a majority of Full Members present and entitled to vote at a General Meeting.

#### **ELECTION OF MANAGEMENT COMMITTEE:**

16. A nomination sheet shall be posted in the Clubhouse on 1st January each year and shall remain there until 14 days before the Annual General Meeting during which time all nominations should be entered together with the Proposer's and Seconder's signatures. Where there are more nominees than vacancies the voting shall be by ballot carried out under the direction of the Secretary/Manager by two scrutineers.

#### **RESCINDING RESOLUTIONS:**

17. No resolution made by the Management Committee Meeting shall be rescinded unless a Notice of Motion in writing has been given at a previous meeting.

#### **CREDIT:**

18. Credit shall not be given to anyone.

#### **BAR HOURS:**

19. The hours during which the bar will be open shall be within those permitted by statute as shall be decided from time to time by the Management Committee.

#### **INSURANCE:**

20. The liability of the Club is strictly limited to damage by fire to any property for which the Club may be legally responsible. Each Member should ensure that any property left on Club premises is insured personally. Personal effects including golf equipment are NOT protected by Club insurance against loss or damage by fire, theft etc.

#### **BYE LAWS:**

21. In the proper exercise of their respective powers (but not further or otherwise) the Management Committee shall have power to make such Bye-Laws and Local Rules for the regulation and conduct of the Club and Course as they may from time to time think necessary, and such Bye-Laws shall remain in force unless altered or rescinded by the Management Committee or at a General Meeting.

#### **TROPHIES:**

22. Winners of Challenge Prizes and Trophies which are the property of the Club shall be fully responsible for their safe custody

**ANIMALS:**

23. No dogs, cats or other pets shall be brought into the Clubhouse or onto the course.

**LOCKERS:**

24. Playing Members may have use of Club lockers on payment in advance of the rental decided by the Management Committee.

A register of locker holders will be displayed in the Clubhouse, and any property found in a locker for which no rental is paid is liable to seizure as the property of the Club and may be used or disposed of in any manner the Management Committee may decide.

**COMPETITIONS:**

25. In all Club competitions the decision of the Competitions Secretary or in his absence the Captain Elect, or in the absence of both the Secretary/Manager shall be binding in all competitions.

**CLUB COLOURS:**

26. The Club colours shall be Blue and Gold.

**RULES OF PLAY:**

27. The Rules of the Game of Golf shall be those of the Royal and Ancient Golf Club of St. Andrews subject only to such Local Rules as the Management Committee may consider necessary for this Club. The Local Rules will be printed on the Club scorecards or displayed in the Clubhouse together with a copy of the Rules of Golf as played by the Royal and Ancient Club.

**ETIQUETTE:**

28. All Members on the Course or in the Clubhouse should be conversant with the Rules of Golf and of normal etiquette. They must observe the Rules themselves and require others to do likewise.

**COMPLAINTS:**

29. In no instance shall a Member reprimand anyone employed by or for the Club. All complaints by a Member shall in the first instance be made to the Secretary/Manager who will, if in his power, deal with them but Members shall have the right to having their complaints submitted to and adjudicated by the Management Committee whose decision shall be final.

**COURSE MAINTENANCE:**

30. The upkeep and maintenance of the Course is at the expense of each Member and it is the duty of all to ensure that divots are replaced correctly and that every care is taken to avoid damage to greens, bunkers and equipment.

**BORROWING:**

31. If at any time the Club in General Meeting shall pass a resolution authorising the Management Committee to borrow money, the Management Committee shall thereupon be empowered to borrow for the purpose of the Club such sum or sums of money at one time or from time to time and at such rate of interest and in such form and manner and upon such security as shall be specified in such resolution and thereupon the Trustees shall, at the direction of the Management Committee, make all such disposition of the Club property or any part thereof and enter into such agreements in relation thereto as the Management Committee may deem proper for giving security for such loans and interest. All Members of the Club whether voting on such resolution or not, and all persons becoming Members of the Club after the passing of such resolution, shall be deemed to have assented to the same as if they had voted in favour of such resolution.

**WINDING UP OF THE CLUB:**

32. . Upon dissolution of the club any remaining assets shall be given or transferred to another registered CASC, a registered charity or the sports governing body for use by them in related community sports.

**GENERAL RULES:**

33. No Member shall injure, take away or permit to be taken away from the Clubhouse, under any pretext whatever, any property of the Club.

34. No paper, notice or placard, written or printed, shall be put up in the Clubhouse or grounds without permission of the Management Committee, the Captain or Secretary/Manager.

35. All Members are required to pay every expense they incur in the Club before leaving the Clubhouse.

36. No Member shall exploit membership of the Club for business purposes without permission of the Management Committee.

37. No Member or visitor may bring refreshments to the Clubhouse unless for official catering purposes.



38. No Member or visitor shall use the Club premises for the purpose of making charitable or other appeals without the permission of the Management Committee.

39. Members playing in competitions from competition tees have priority on the Course.

40. The Course is made available to certain categories of membership at certain times as decreed by the Management Committee and indicated by Notice posted within the Clubhouse. On such occasions the first tee shall be closed in favour of the categories referred to.

41. Junior Members with a handicap of 18 or less may enter all Senior Competitions

Any Junior member under the age of 18 at midnight on 31<sup>st</sup> August will be eligible to enter the following calendar year's Junior Competitions so long as they have paid the relevant Junior fee.

42. The following standards of dress shall apply:

(a) On the course - playing golf.

(i) Only bona fide golf shoes are to be worn. These do not include trainers except in the case of Junior Members in their first year of membership.

(ii) No track suits.

(iii) No denim jeans.

(iv) Shirts should be considered to be acceptable golf wear

(v) Shorts should be tailored. These do not include running or football shorts.

Anyone not observing these rules will be asked to leave the course.

(b) Within the Clubhouse:

A reasonable standard of dress must be maintained in the Clubhouse at all times. Members are requested to wear smart casual clothing.

Anyone not complying with the above will be asked to conform to the dress code.
